The Amish "Sunrise" quilt which appeared in the Sheldon Art Gallery Quilt Show in 1974, will be shown in the "Patch In Time #4 Quilt Show" in San Francisco, California June 30 to July 3, 1979.

This quilt belongs to Mr. and Mrs. E. A. Olson of Lincoln. They were contacted about the quilt by Joyce Gross of the Mill Valley Quilt Authority, and editor of "Quilters' Journal"."

DATING PRINTS

On April 9 Gail Potter presented a very scholarly program to the Lincol-Quilters Guild. Drawing from her training and experience as Textile Curator for Nebraska Historical Society, Gail illustrated through slides methods used in dating textiles. She spoke of the value of old textile sample cards and in particular the more accessible reference source of old photographs.

Guild members were intrigued to learn of the hundreds of quilts presently stored in the Society's collection. We hope a showing can be arranged in the future.

At the end of her presentation Gail discussed the many old quilts brought by the audience for her evaluation. By sharing her knowledge Gail enabled us to increase our expertise in determining the age and value of our quilts. Gail stressed the more you work with fabrics the easier it is to get a feel for the period you are dealing with. - Pat Hackley
